

Data protection information for suppliers

Data protection information in accordance with Art. 19 Federal Data Protection Act (FADP) of 25th September 2020.

The collection of data is subject to Swiss data protection law, in particular in accordance with the Federal Act on Data Protection (FADP) and any applicable foreign data protection law such as the General Data Protection Regulation (GDPR) of the European Union (EU). The EU recognises that Swiss data protection law ensures adequate data protection.

We may amend our data protection information at any time by publishing it on this website.

Purpose of processing

We process your personal data, e.g. for ordering products and services, keeping the accounts, filing documents and other administrative work, asserting claims, etc.

This involves the following categories of data:

- Contact data (name, address, telephone number and email address).
- Identification data (signature)
- · Information on ordered products and services
- Contract content and agreed conditions
- bank and payment data
- other data that you voluntarily provide to us in the course of processing the contractual relationship or in the course of initiating a contract.

The processing of the data is necessary for the fulfilment of the above-mentioned purposes.

Categories of recipients

Personal data may be disclosed to the following categories of recipients:

- Software solution providers
- IT service providers
- sub-service providers
- Authorities and tax administrations

All recipients have been carefully selected and, where necessary, contractually mandated in accordance with Art 9 DPA. They are bound by our directives, have appropriate technical and organisational measures in place and are regularly audited.

In addition, disclosure may take place in the event of official enquiries or legal proceedings if this is absolutely necessary.

Disclosure of personal data abroad

When processing your data, it may also be transferred abroad, e.g.

- for the dispatch of products
- when forwarding personal data to other companies in the group or to service providers.

Under certain circumstances, we may also transfer data to third parties abroad who are involved in the processing of the contract (e.g. to authorities and courts), as well as to other bodies such as foreign tax authorities.

Your data may therefore be processed worldwide, including outside Switzerland or the EU or the European Economic Area (i.e. also in so-called third countries). We therefore take the measures required by law to reduce the risk of government access abroad authorised by foreign legislation.

Storage period

Your data will be stored for at least as long as is necessary to achieve the aforementioned purposes and as long as we are legally or contractually obliged to store it.

Your rights

You have the right to request information about the processing of your personal data free of charge at any time. Further rights such as the right to data deletion, data correction, restriction of data processing and the right to data transfer exist within the legally prescribed framework.

You also have the right to lodge a complaint with a competent supervisory authority. The competent supervisory authority for data protection in Switzerland is the Federal Data Protection and Information Commissioner (FDPIC).
